FEE SCHEDULE FOR RACE EVENTS

Use of Lakeshore Drive with open grassy area for race event start/end point:

Churches, Schools, Individuals, and Non-profit ventures:

\$1.25 per participant with a \$300.00 minimum

Commercial and all other endeavors:

\$1.25 per participant with a \$500.00 minimum

Use of Lakeshore Drive including use of a Shelter for a race event start/end point:

Churches, Schools, Individuals, and Non-profit ventures:

\$300 for use of the shelter ***plus*** \$1.25 per participant fee

Commercial and all other endeavors:

\$500 for use of the shelter ***plus*** \$1.25 per participant fee

***** All events serving alcohol require a Letter of Authorization and are considered commercial events *****

FEE SCHEDULE - USE OF PARKING LOTS LOCATED ON OR NEAR LAKESHORE DRIVE

Parking lots along Lakeshore Drive are \$500.00 per day

Parking lot located near Beauregard on Lakeshore Drive is \$450.00 (unused portion)

Parking lot located across from Landry's Restaurant is \$1,000.00 per day for the entire lot

INSURANCE REQUIREMENTS

- a. \$1,000,000 General Liability Per Occurrence
- b. \$2,000,000 General Liability Aggregate
- c. \$1,000,000 Automobile Liability Per Occurrence
(Coverage to include all automobiles/equipment)
- d. Statutory Workers' Compensation
- e. NON-FLOOD PROTECTION ASSET MANAGEMENT AUTHORITY (NFPAMA),
ORLEANS LEVEE DISTRICT (OLD), and SOUTHEAST LOUISIANA FLOOD
PROTECTION AUTHORITY – EAST (SLFPA-E) must be named as Certificate Holders
and Additional Insureds
- f. Waiver of Subrogation in favor of the NON-FLOOD PROTECTION ASSET
MANAGEMENT AUTHORITY, ORLEANS LEVEE DISTRICT, and SOUTHEAST
LOUISIANA FLOOD PROTECTION AUTHORITY – EAST on all lines of coverage
- g. A thirty-day cancellation clause
